## MAJOR CONTRIBUTORS:

- Dr. Carter's reaction to "Deterring Acquisition:" Believes motivations to acquire need more clarity beyond just security/political. Suggested to use five categories he and Dr. Fetter published. (NOTE: Asked J51 staff to research Dr. Carter's writing to find his five motivations.)
- Asked if any one was working changes to Positive Security Assurances Regime. Col Shannahan noted that ACDA was leading charge as part of NPT prep. On both this topic and negative assurances, Dr Carter wants this group and WG 1 to address the issue: Why does it matter to DoD if these Assurances are changed? "We must clearly draw out the implications to this department of changing PSA/NSA/No First Use Declaratory Policy."
- At previous working group chairman's meeting, Dr. Carter indicated that he wanted to focus on four approaches to US. nuclear posture.
  - -- Effects/support to negotiating process.
  - -- How do postures affect ability to employ capabilities?
  - -- How does posture deter?
  - -- Where might posture deter acquisition?
