2. (U) The following topics were discussed:

- a. (U) CDR [redacted] briefed minutes of the last meeting. The minutes were approved.
- b. (U) CDR [redacted] and CDR [redacted] briefed their last trip to the Pentagon to discuss the Theater Nuclear Support model with the Joint Staff and Service staff officers. This memo constitutes the trip report for that visit. Several Joint Staff misconceptions were dispelled at the meeting. The following issues required action or discussion at STRATCOM:

(1) (U) Planning. Joint Staff action officers posed several questions regarding planning capability, particularly with respect to follow-on capabilities. We had previously discussed most of the issues in the NSNF Working Group.

- (U) JS/J7 action officers agreed to consider a STRATCOM proposal to divorce nuclear planning (reflected in Tabs A, B and C to the theater CINC's Appendix 1 to Annex C) from the normal deliberative planning timetable. This proposal offers the theater CINC the flexibility to establish, alter and maintain their nuclear target data base independent of the JOPES development and maintenance timetable.
